NOW THE DOORS ARE CLOSED...BECAUSE EVEN THE DOORS TO MEMORIAL HOSPITAL HAVE TAKEN A LEAVE OF WORK AND SIMPLY STOPPED WORKING.

MANY THINGS HAVE SIMPLY “STOPPED WORKING” AT MEMORIAL HOSPITAL. BUT IT'S CERTAINLY NOT DUE TO A LACK OF TAX DOLLARS, WITH THE RECENT .45 CENT TAX ADDED ON TOP OF THE MILL LEVY.
